The representatives of Australia, Japan and New Zealand met to resume the Sixth Annual meeting of the Commission for the Conservation of Southern Bluefin Tuna on 18 April 2001 in Sydney. A list of participants is shown in **Attachment A**.

The Chair, Mr Don Banfield, advised that two items were outstanding from the Second Part of CCSBT 6, appointment of the Executive Secretary and the election of the Chair and Vice-Chair for CCSBT 7. He advised that the process for selecting a new Executive Secretary had been completed and proposed that Mr Brian Macdonald be appointed to the position. The Commission endorsed the appointment and thanked the retiring Executive Secretary, Mr Campbell McGregor, for his efforts in setting up the Secretariat and assisting the Commission in progressing its work during the last five years.

The Commission elected Mr Bill Mansfield (New Zealand) as Chair and Mr Shiro Yuge (Japan) as Vice-Chair for CCSBT7, and agreed to close the Sixth Annual Meeting of the Commission.
