Secretariat Update on the Enhancements to the Existing Transhipment Memorandum/Letter of Understanding with ICCAT and the IOTC ICCAT 及び IOTC との既存の転載に関する了解覚書の強化に関する事務局からのアップデート

## 1. Introduction

序論

The Eighteenth meeting of the Compliance Committee (CC18) agreed to a Workplan item for the Secretariat to:

第18回遵守委員会会合(CC18)は、その作業計画事項として事務局が以下を行うことに合意した。

"Examine Transhipment MoUs with ICCAT and IOTC with a view to enhancing them to allow IOTC/ICCAT to share Transhipment Supply Declarations with CCSBT."

「IOTC/ICCAT の転載補給申告書を CCSBT と共有できるように ICCAT 及び IOTC との転載 MoU を強化する観点から、これらを精査する。」

This paper provides an update on the work to review and enhance these agreements. 本文書では、これらの覚書のレビュー及び強化にかかる作業に関するアップデートを提示する。

## 2. Background 背景

In 2023, the CCSBT updated its Transhipment Resolution with text to reflect amendments and updates that both the ICCAT and IOTC made to their Transhipment Resolutions. Specifically, the CCSBT added paragraph 25 that stated that CCSBT would consider the introduction of supply declaration at the Thirty-Second Annual Meeting of the Commission and Extended Commission (CCSBT 32), after taking into account the effectiveness of the supply declaration that were introduced in ICCAT in 2022<sup>1</sup>.

2023年において、CCSBTは、ICCAT及びIOTCの両機関の転載決議に対する改正及びアップデートの内容を反映するべく、CCSBT転載決議の文言を改正した。特に、CCSBT決議に追加されたパラグラフ 25 では、2022年以降にICCATにおいて導入されている補給申告書の有効性を考慮した上で、2025年のCCSBT 32会合において補給申告書の導入を検討することとしている。

IOTC also agreed to introduce requirements for the provision of supply declarations by carrier vessels into their transhipment conservation and management measure (CMM) in May 2024 and these requirements came into effect in September 2024.

また IOTC は、2024年5月に IOTC の転載保存管理措置 (CMM) に運搬船による補給申告書の提出に関する要件を導入することに合意し、これらの要件は2024年9月に発効した。

During CC18, Members also considered but decided not to include a paragraph on 'Availability of reports' (similar to ICCAT's paragraph 27). The CCSBT-considered amendment would have required that CCSBT make supply declarations available on the private area of its own website to facilitate the implementation of 'Resolution for a CCSBT Scheme for Minimum Standards for Inspection in Port'. However, Members decided not to add in this paragraph as it would be duplicative of ICCAT's and IOTC's existing requirements. Instead, it was decided that a more efficient solution for CCSBT would be to explore a mechanism allowing ICCAT/IOTC to share the supply declarations with CCSBT or potentially allow CCSBT Members to access relevant declarations directly via the ICCAT and IOTC websites. To facilitate either of these processes, details of the sharing arrangement would most likely need to be incorporated into the relevant MoU/LoU.

またメンバーは、CC 18 において「報告書の利用可能性」に関するパラグラフ (ICCAT 勧告パラグラフ 27 に類似した規定)について検討したが、これを導入しないことを決定した。CCSBT が検討した改正では、「港内検査の最低基準を定めた CCSBT 制度に関する決議」の実施を促進するべく、CCSBT ウェブサイトのプライベートエリア上で補給申告書を利用可能とすることが必要となる。しかしながら、これは ICCAT 及び IOTC の既存の要件と重複するので、メンバーは当該パラグラフは追加しないことを決定した。その代わりに、CCSBT にとってより効率的な対応策として、ICCAT/IOTC が CCSBT に転載申告書を共有できるようにするか、又は CCSBT メンバーが ICCAT 及び IOTC ウェブサイトの関連申告書に直接アクセスできるようにする可能性を検討することが決定された。これらのプロセスのいずれかを促進するためには、情報共有に関する取決めの詳細を関連する MoU/LoU に記載する必要がある。

The Secretariat worked with the ICCAT Secretariat to draft an updated MoU which was subsequently endorsed by the Thirty-First Annual Meeting of the Commission and Extended Commission (CCSBT 31).

事務局は、ICCAT事務局とともに改訂 MoU 案にかかる作業を行い、その後の第31回委員会年次会合(CCSBT31)に付属する拡大委員会により改訂案が承認された。

The Secretariat advised the Nineteenth Meeting of the Compliance Committee (CC19), the IOTC is no longer able to sign or update collaboration agreements directly, as the IOTC does not have a legal identity independent of the United Nations Food and Agriculture Organisation (FAO). A draft FAO MOU was provided for consideration by CC19 and CCSBT31 endorsed the CCSBT Secretariat's continued engagement with IOTC and FAO to execute the high-level MOU between CCSBT and FAO. This would then allow for a technical collaboration agreement to be agreed with the IOTC.

事務局は、第19回遵守委員会会合(CC 19)に対し、IOTC は国連食糧農業機関(FAO)から独立した法人格を持たないので、IOTC が改訂協力協定に直接署名したり改訂を行うことができないことを報告した。CC 19による検討に向けて FAO とのMoU 案が提出され、CCSBT 31 は、CCSBT と FAO との間のハイレベル MoU を締結するべく、CCSBT 事務局が IOTC 及び FAO と引き続き協議することを承認した。これによって IOTC との間で専門的な協力協定に合意することが可能となる。

# 3. Memorandum of Understanding with ICCAT ICCAT との了解覚書

The updated MOU with ICCAT was executed in early February 2025, following the endorsement of the updated MOU at ICCAT's annual meetings in late 2024. A copy of the updated and executed MOU is included as **Attachment A** to this paper.

ICCAT との改訂 MoU は、2024 年末の ICCAT 年次会合での改訂 MoU の承認を受けて、2025 年 2 月上旬に発効した。ICCAT との現行 MoU の写しは本文書**別紙 A** のとおりである。

Following execution of the MOU, the ICCAT Secretariat notified its CPCs of its intent to grant access to ICCAT Supply Declaration records to the CCSBT Secretariat and allowed CPCs a period to notify any objection to this. No objections were received, and the CCSBT Secretariat was provided access to ICCAT Supply Declaration information in April 2025. This access to ICCAT Supply Declarations is further discussed in paper <a href="CCSBT-CC/2510/14">CCSBT-CC/2510/14</a>.

MoU の発効後、ICCAT 事務局は ICCAT の CPC に対し、CPC がこれへの反対意見を通知することを可能とする期間と合わせて、CCSBT 事務局に対して ICCAT 補給申告書記録へのアクセス権を付与する意向について通知した。CPC からの反対はなく、CCSBT 事務局は 2025 年 4 月に ICCAT 補給申告書情報へのアクセス権が与えられた。ICCAT 補給申告書へのアクセスに関しては、文書 CCSBT-CC/2510/14 でさらに検討した。

# 4. Memorandum of Understanding with FAO FAO との了解覚書

Following the CCSBT annual meetings in 2024, the CCSBT and IOTC Secretariats continued to work together on the draft updated MoU with FAO and the Secretariat was notified early in 2025 that the MoU had been passed through the second stage of operational clearance at FAO. During this process the FAO responded to the CCSBT comments in the template and accepted almost all of the proposed changes. FAO also made some small adjustments to the draft MOU based on updates they had made to their MoU template in August 2024, but these resulted in only minor changes that did not impact the intent of the MoU that was agreed by Members at CCSBT31.

2024年のCCSBT年次会合後、CCSBT及びIOTC事務局は引き続きFAOとのMoUのアップデート案について共同で作業を行った。事務局は、2025年初頭にMoUがFAO内部の承認プロセスにおける第二段階を通過したとの通知を受けた。このプロセスの中で、FAOは、テンプレート中のCCSBTからのコメントに回答し、提案された修正の大部分が受け入れられた。またFAOは、2024年8月に行われたMoUテンプレートそのもののアップデートに基づきMoU案にいくつかの微修正を加えたものの、これらはマイナーな修正であり、CCSBT31においてメンバーが合意したMoUの意図に影響を及ぼすものではなかった。

The only substantive change to the MoU that was reviewed by CC19, and agreed by CCSBT31, was the addition to the MoU of a workplan which outlines the broad collaboration areas between IOTC and CCSBT. The Secretariat reviewed and updated the draft workplan that was provided by FAO and an updated workplan and MoU were then provided back to the IOTC Secretariat in mid-January 2025 for consideration by the IOTC Commission. In May 2025, the Twenty Ninth Session of the Indian Ocean Commission endorsed the workplan for inclusion in the overall MoU to be agreed with FAO<sup>3</sup>. A copy of the Workplan is included as **Attachment B** to this paper.

CC 19 がレビューし CCSBT 31 が合意した MoU 案との唯一の大きな違いは、IOTC と CCSBT との間における広範な協力分野を概説した作業計画が MoU に追加されたことである。事務局は、FAO から提示された作業計画案をレビュー及びアップデートし、IOTC 委員会による検討に向けて、2025 年 1 月中旬に IOTC 事務局に対して修正作業計画案及び MoU 案が返送された。2025 年 5 月の第 29 回 IOTC 年次会合は、FAO との間で合意される全体的な MoU に当該作業計画を取り入れることを承認した。当該作業計画の写しを本文書別紙  $\mathbf{B}$  に示した。

Following the approval of the workplan at the IOTC Commission meeting, the documents were sent back to FAO for the next step of the clearance process. Updated Memorandum of Understanding between the CCSBT¹ and ICCAT² Secretariats for Transhipment at sea by Large-Scale Tuna Longline Fishing Vessels (LSTLVs)

#### Introduction

- The ICCAT has adopted a Recommendation3 and implemented a program for transhipment at sea by large-scale longline pelagic fishing vessels (LSTLVs)4 within the ICCAT Convention area. The CCSBT has adopted a similar Resolution5 for tuna longline fishing vessels with freezing capacity that applies globally to all transhipments involving southern bluefin tuna (SBT). Each Secretariat is in charge of administering the program within its jurisdiction.
- The two Commissions have overlapping jurisdiction in the Atlantic Ocean, where the CCSBT Resolution
  and ICCAT Recommendation are almost identical and most vessels that are required to comply with
  the CCSBT Resolution are also required to comply with the ICCAT Recommendation.
- This Memorandum of Understanding (MOU) has been established to minimise the duplication of work and to minimise the associated costs for those that are required to comply with both the CCSBT Resolution and ICCAT Recommendation.

### Scope of this Memorandum of Understanding

- 4. This MOU applies to transhipments at sea involving southern bluefin tuna (SBT) within the ICCAT Convention area, by LSTLVs with freezing capacity that are Members/Contracting Parties (CPCs)6 of both CCSBT and ICCAT and is further restricted to CPCs that are participating in both CCSBT's and ICCAT's regional observer program.
- 5. CCSBT and ICCAT will notify each other of any changes in their Members/CPCs that may affect the application of this MOU.

## Arrangement between CCSBT and ICCAT

- 6. All provisions of the ICCAT transhipment Recommendation will continue to apply to transhipments at sea that fall within this arrangement.
- 7. All provisions of the CCSBT transhipment Resolution will also apply to transhipments at sea that fall within this arrangement, except that:
  - a) To enable a single Transhipment Declaration form to be completed for transhipment by an LSTLV, an ICCAT Transhipment Declaration form may be used instead of the CCSBT Transhipment Declaration form. This only applies while the ICCAT and CCSBT forms remain compatible unless there is agreement to the contrary. Furthermore, transmission of this form by Carrier Vessel masters to the ICCAT Secretariat is deemed to also be a transmission to the CCSBT Secretariat. The ICCAT Secretariat will transmit these documents to the CCSBT Secretariat without delay.
  - b) ICCAT Register Numbers for LSTLVs and Carrier Vessels may be used instead of the CCSBT equivalents. The CCSBT Secretariat will conduct the necessary conversions between ICCAT and CCSBT registration numbers.

- c) To enable a single set of Transhipment Observers to be used, ICCAT Transhipment Observers will be deemed to be CCSBT Transhipment Observers providing these observers meet the standards established in the CCSBT Transhipment Resolution and providing that the CCSBT Secretariat is informed. In no case will ICCAT Transhipment Observers be required to observe transhipments outside of the ICCAT Convention Area.
- d) The Consortium that operates the ICCAT program will issue a second report dealing exclusively with transfers that include SBT (i.e. omitting any transfers where no SBT were transhipped) from vessels subject to this MOU. Transmission of such Observer Reports by the Transhipment Observer to the ICCAT Secretariat is deemed to also be a transmission to the CCSBT Secretariat. The ICCAT Secretariat will re-transmit these documents to the CCSBT Secretariat without delay.
- e) CCSBT is considering<sup>7</sup> the introduction of a requirement to provide a supply declaration anytime an authorised carrier vessel provides supply services to another vessel at sea that has SBT on board. Supply declarations have been a requirement in ICCAT since 2022 and these are published on the secure part of the ICCAT website.
- f) Should CCSBT introduce a requirement for supply declarations, then an ICCAT Supply Declaration form may be used instead of the CCSBT Supply Declaration form. This only applies while the ICCAT and CCSBT forms remain compatible, unless there is agreement to the contrary.
- 8. The combined effect of paragraphs 6 and 7 is that the ICCAT Secretariat and Transhipment Observers will continue to follow the requirements of the ICCAT Recommendation with the additions that:
  - a) The ICCAT and CCSBT Secretariats will advise each other regarding any planned or actual changes to their Recommendations/Resolutions for at sea transhipment including the Transhipment Declaration form.
  - b) The ICCAT Secretariat will transmit copies of Observer Deployment requests, Transhipment Declarations and Observer Reports for all transhipments involving SBT to the CCSBT Secretariat without delay.
  - c) In addition to the experience and training required by the ICCAT Transhipment at sea Recommendation, ICCAT Transhipment Observers that observe transhipments of SBT will have sufficient experience and knowledge to:
    - identify southern bluefin tuna; and
    - have a satisfactory knowledge of the CCSBT conservation and management measures.
  - d) An up-to-date list of ICCAT Transhipment Observers will be maintained and annually provided to the CCSBT Secretariat by the ICCAT Secretariat.
  - e) When ICCAT is informed that an observer deployment will involve transhipments of SBT, ICCAT will notify CCSBT prior to dispatching the observer so that the CCSBT Secretariat can check the validity of authorisations of the Fishing Vessels and Carrier Vessels against the published list of CCSBT Authorised Fishing Vessels and CCSBT Authorised Carrier Vessels respectively.
  - f) To support CCSBT in their consideration, and potential introduction of, Supply Declarations, the ICCAT Secretariat will provide to nominated and authorised staff within the CCSBT Secretariat, access to the supply declaration data held on the secure part of the ICCAT website. The access to, and use of, this data by CCSBT shall be in accordance with the provisions of the Rules and Procedures for the Protection, Access to, and Dissemination of Data Compiled by ICCAT and the Rules and Procedures for the Protection, Access to, and Dissemination of Data Compiled by the CCSBT.
  - g) In addition to tasks specified in the ICCAT Transhipment Recommendation, Transhipment Observers that observe transhipments of SBT will:

- Conduct checks on the Fishing Vessel intending to tranship in accordance with section 6 a) i) of Annex 2 of the CCSBT Transhipment Resolution.
- Certify the transhipment verification section of the CCSBT CDS documentation to indicate that
  the transhipment details (date, name and registration of carrier vessel) were filled in correctly
  and that the transhipment of product was observed according to the CCSBT Transhipment
  Resolution8.
- 9. Additional costs imposed on the ICCAT observer program resulting from this MOU will be covered by CCSBT. The costs associated with additional training, additional reports, and insurance required for observers, will be calculated by the Consortium that operates the ICCAT program and transmitted to the CCSBT Secretariat via the ICCAT Secretariat. The CCSBT Secretariat will be responsible for recovering these costs from the CPCs concerned.
- 10. The ICCAT and CCSBT Secretariats will cooperate to improve the efficiency of the sharing of data that is covered by this MOU, provided that it remains consistent with the provisions of this MOU and each organisations respective procedures and data and confidentiality rules.
- 11. This MOU comes into effect for twelve months from the date of entry into force noted below. It will be automatically renewed for another twelve months each year, unless otherwise decided by either the CCSBT or ICCAT Secretariat and informed to the other in writing. Either of the Secretariats may terminate the MOU at any time by written notice to the other Secretariat.
- 12. This MOU replaces that signed on 1 July 2015 from the date of its entry into force.
