Purpose

Background

At CCSBT 30, Members adopted a revised Strategic Plan¹ that outlines a common vision for how the Commission will operate in order to meet the overall objective of the Convention. The Strategic Plan also provides the following vision and set of goals in support of the overall objective.

Management of SBT

SBT の管理

The Commission agrees the SBT tuna stock is to be managed at a biomass level that supports the maximum sustainable yield, and the risks related to fishing for SBT and impacts from fishing for SBT on ecologically related species are mitigated.

委員会は、最大持続生産量を維持する資源レベルで SBT 資源を管理し、SBT 漁業に関連するリスク及び生態学的関連種に対する SBT 漁業の影響を緩和することに合意する。

- This includes strategies concerning stock rebuilding, allocation and ecologically related species.
これには、資源の再建、国別配分量及び生態学的関連種に関する戦略が含まれる。

- This also includes consideration and review of all other risks including, but not limited to, marine pollution and human safety.
また、これには、海洋汚染及び人への安全性を含むがこれに限定されないその他全てのリスクにかかる検討及びレビューが含まれる。

Operation/Administration of the Commission and Secretariat **委員会及び事務局の運営／管理**

It was agreed the Commission should operate effectively and efficiently, to responsibly manage fishing for SBT.

責任ある SBT 漁業の管理のため、委員会は効果的かつ効率的に運営すべきことが合意された。

- This includes strategies for effective and efficient operation of Commission, its subsidiary bodies and Secretariat, including harmonisation with other RFMOs.
これには、委員会、委員会の補助機関及び事務局の効果的かつ効率的な運営のための戦略（他の RFMO との調和を含む）が含まれる。

Participation and implementation by Members, including Compliance. **メンバーの参加及び履行（遵守を含む）**

Members are actively participating in management of SBT through the Commission and implementing its decisions.

- This includes strategies concerning MCS, sanctions and assistance to developing countries.

Strategic Plan Items of Relevance to the Extended Commission **拡大委員会に関連する戦略計画の行動事項**

The Strategy includes several actions that are to be carried out by the Extended Commission (EC). The following elements of the Action Plan and Ongoing Work Plan have been identified as relevant to the work of the EC.

戦略計画には、拡大委員会（EC）によって実行されるべき複数の行動事項が含まれている。EC の作業に関連するものとして特定された行動計画及び継続的作業計画の要素は以下のとおりである。

Action Plan 行動計画

- **PR2021-29:** Due to the central importance of spawning and recruitment for stock rebuilding, additional efforts should be made to develop, in Indonesian waters, spatio-temporal restrictions, equitable and compatible with the rest of the management strategy.
資源再建には産卵及び加入が最も重要であることから、インドネシア海域において、その他の管理戦略と公平かつ相互的な時空間的規制を策定するためのさ

らなる努力がなされるべきである。

- **PR2021-07:** Improve transparency by providing and making public, historical data and information that are not currently accessible in the public domain.
現状では公開されていない過去のデータ及び情報を提供及び公開し、透明性を改善する。
- **PR2021-72:** Formalise a reserve/savings fund to be utilised in extraordinary circumstances.
極めて特殊な状況において利用する予備費／貯蓄基金を正式化する。
- **PR2021-73:** Develop mechanisms to improve communication between the Finance and Administration Committee and various subsidiary bodies.
財政運営委員会と各種補助機関との間のコミュニケーションを改善するためのメカニズムを策定する。
- **PR2021-31:** Review the existing allocation mechanism to ensure that it reflects the current makeup of the Membership and principles of international law.
現在のメンバーの構成及び国際法の原則を反映するよう確保するため、既存の配分メカニズムをレビューする。
- **PR2021-32:** Modify the CCSBT Convention to include modern fisheries management concepts agreed by Members at the international level.
国際的なレベルでメンバーによって合意された近代的な漁業管理の概念を取り入れるべく、CCSBT 条約を改正する。
- **PR2021-34:** The CCSBT should consider alternative decisionmaking models in the CCSBT Convention modernising processes.
CCSBT は、CCSBT 条約を近代化するプロセスにおいて、代替的な意思決定方式を検討すべきである。
- The CCSBT should review transparency of decision-making by reviewing the CCSBT's Rules of Procedure or other options.
CCSBT は、CCSBT 手続規則の見直し又はその他のオプションにより、意思決定にかかる透明性をレビューすべきである。
- **PR2021-35:** The CCSBT should consider developing an alternative approach to dispute settlement/ conflict resolution to avoid the potential for future stalemates that could significantly compromise the conservation and management of SBT resources.
CCSBT は、SBT 資源の保存管理を相当程度妥協させるような将来の膠着状態を避けるため、紛争解決／対立解決を行うための代替的な手法の策定を真剣に検討するよう勧告する。
- **PR2021-58:** Access to the CCSBT compendium of measures is made available on the public portion of the CCSBT website.
CCSBT 措置総覧へのアクセスは、CCSBT ウェブサイトの一般エリアから利用可能とすべきである。
- Improve existing guidelines to determine what, if any, allocation should be made to new Members and CNMs.
必要が生じた場合に新メンバー及び CNM に対してどのような配分をすべきかについて決定する際の既存のガイドラインを改善する。
- Consider the introduction of a science management dialogue to be held, as required, between scientists and fisheries managers
必要に応じて、科学者と漁業行政官との間に科学的管理に関する対話の機会を導入することを検討する。

- **PR2021-22:** Using the recommendations from the Performance Review, formulate and implement a capacity-building work plan to improve data collection, scientific analysis, and compliance-related activities.
データ収集、科学的解析及び遵守関連活動を改善するためのキャパシティ・ビルディングに関する作業計画を策定し、これを実施する。

Ongoing Work Plan

継続的作業計画

- **PR2021-01:** Members continue to support the MP, by remaining within their allocation limits, and eliminating areas of uncertainty such as Non-Member catches that could undermine its performance.
メンバーは、それぞれの配分量の上限を遵守し、また MP のパフォーマンスを減殺するおそれがある非メンバー漁獲量といった不確実性のある分野を排除することにより、引き続き MP をサポートする。
- **PR2021-24:** CCSBT should continue to implement CMMs based on ESC and ERSWG advice for both target and non-target species.
CCSBT は、漁獲対象種及び非漁獲対象種の両方に関し、ESC 及び ERSWG からの助言に基づく CMM を引き続き実施すべきである。
- **PR2021-71:** Maintain a healthy flow of income (through Member's contribution and other sources) that exceeds CCSBT's expenses.
CCSBT による支出を上回る（メンバーからの分担金及びその他のソースによる）健全な収入フローを維持する。
- Apply the Quality Assurance Review (QAR) Program to countries and/or entities who join the Commission in the future. Ongoing QAR program for existing Members is subject to the decision by the EC based on further advice from the Compliance Committee.
将来的に委員会に加盟した国及び／又は主体に対し、品質保証レビュー（QAR）を適用する。既存のメンバーに対する継続的な QAR プログラムについては、遵守委員会からのさらなる助言に基づく EC の決定次第となる。
- **PR2021-74:** Encourage earlier nominations for Chair of CCSBT from hosting Members ahead of Commission meetings
次の委員会会合を主催するメンバーによる CCSBT 議長の早期推薦を奨励する。
- **PR2021-75:** Encourage the re-election of Chairs for up to 4 years as is allowed in 4(1) of the Rules of Procedure to provide better governance of the CCSBT.
CCSBT のガバナンスを改善するため、手続規則 4 (1) の規定に基づく最大 4 年間までの議長の再任を奨励する。
- **PR2021-57:** Process for review of external documents, including possible non-compliance on the part of Members, should be monitored to ensure that it does not create a barrier for external engagement with the CCSBT.
CCSBT への外部者による参加の障害とならないよう確保するため、外部文書（一部のメンバーの非遵守の可能性を含むもの）のレビュープロセスは監視されるべきである。
- Encourage non-Members to increase engagement in CCSBT processes, including joining the CCSBT and utilising the CDS
非メンバーに対し、CCSBT への加盟及び CDS の活用を含め、CCSBT のプロセスへの関与を高めるよう奨励する。

- **PR2021-44:** Continue to formalise and strengthen information sharing with other RFMO secretariats and alternative information sources.
他の RFMO 事務局及び代替的な情報源との情報交換の公式化及び強化を継続する。
- **PR2021-56:** Use of head of delegation meetings at the EC should be minimised to the extent possible.
EC 会合における代表団長会議の利用は、可能な限り最小限とすべきである。
- **PR2021-64:** Members look for additional opportunities to engage with one another outside of the traditional meeting dates of the CCSBT to ensure that the limited time available at CCSBT meetings is maximised.
メンバーは、CCSBT 会合の際に利用できる限られた時間を最大化するよう確保するため、CCSBT における従来の会議日程とは別に、メンバーが交流するための追加的な機会を模索する。
- **PR2021-63:** Members look for opportunities to continue and reinvigorate the cooperation instigated through the Kobe Process.
メンバーは、神戸プロセスを通じて開始された協力関係を継続及び活性化させるための機会を探索する。
- **PR2021-68:** Continue to engage with Kobe intersessional processes, particularly as they relate to areas of shared interests.
休会期間中の神戸プロセス（特に共通の関心を有する分野に関連するプロセス）との関与を継続する。

Monitoring and Implementation

モニタリング及び実施

To ensure that the objectives of the Strategic Plan are met, the plan outlines a process that commits to annual monitoring and reporting against the actions agreed under the plan. The EC has been tasked to review the progress made with the Secretariat holding responsibility for compiling the information necessary for the EC to conduct its annual monitoring review. 戦略計画の目的が履行されるよう確保するため、同計画は、計画の下に合意された行動事項に対するモニタリング及び報告を毎年実施することを定めたプロセスを総括している。EC は同計画の進捗状況についてレビューする任務を課されており、また事務局には EC が当該年次モニタリングレビューを実施するために必要な情報を取りまとめる責任が課されている。

The Strategic Plan states that “Subsidiary bodies holding responsibility for particular action items are expected to report back on the progress of those activities as part of their respective meeting reports”.

戦略計画は、「特定の行動事項に責任を負う補助機関は、それぞれの会合報告書の一部として、それぞれの行動の進捗状況について報告することが期待される」と記載している。

As a subsidiary body, the ESC has reported back its progress and it is included in **Attachment A**. There is no progress report from the Ecologically Related Species Working Group (as no meeting in this year) and the Compliance Committee (as its meeting had not concluded at the time of writing).

Initial Recommendations from Secretariat

事務局からの予備的勧告

The Secretariat has provided draft responses to some of the actions in the Action Plan which relate to the upcoming year. Some of the items worth noting include the following:

事務局は、来年に関連する行動計画事項の一部にかかる対応案を示した。特筆すべき事項としては以下が挙げられる。

1. An action that would move the existing CCSBT compendium from the Private Area of the website to make it available to the public. **PR2021-07**

既存の CCSBT 措置総覧を Web サイトのプライベートエリアから移し、一般エリアで閲覧可能とする行動。 **PR2021-07**

- This recommendation is based on previous discussions with Members on this topic. The information currently available in the compendium is generated entirely from meeting reports and intersessional decisions. This information is therefore not sensitive and can be released with minimal risk to the Commission.

この勧告はメンバーとの本件にかかる従前の議論に基づくものである。措置総覧で現在利用可能とされている情報は全て会合報告書及び休会期間中の意思決定から生成されたものである。したがって、これらの情報は機密性が高いものではなく、これを公開することによる委員会に対するリスクは最小限である。

2. To continue FAC pre-meeting engagement along with participation from subsidiary body Chairs in the FAC. **PR2021-73**

FAC への補助機関の議長による参加と合わせた、会合前の FAC 事前協議の継続。 **PR2021-73**

- Earlier FAC engagement is encouraged as it may stimulate inter-delegation conversations between managers and scientists ahead of each year's ESC. Participation from subsidiary body Chair also provides the FAC with the ability to seek clarification on the advice received from subsidiary bodies.

各年の ESC 会合に先立って代表団内の行政官及び科学者間の協議を促す観点から、早期の FAC 協議が奨励される。また、補助機関の議長が参加することにより、FAC が補助機関から受領した助言に関する明確化を求めることが可能となる。

The Secretariat is also not recommending any further action in relation to potential changes to CCSBT's Rules of Procedure.

また事務局は、CCSBT 手続規則の改訂に関するさらなる行動は勧告しない。

The EC was asked to consider revising the Rules of Procedure (or other alternatives) to bring increased transparency to the decision-making process. The Secretariat has found that although broad criticisms relating to the lack of RFMO transparency are common across civil society organisations, these are not directly targeted at CCSBT and often lament practices that are not carried out in this Commission. For instance, the CCSBT allows observers to engage in the proceedings of all subsidiary bodies, which is not always the case in other

RFMOs. Decision of the Commission are also typically available to the public within days of the close of the meeting.

EC は、意思決定プロセスにおける透明性を向上させるための手続規則の改正（又は代替的な手段）を検討するよう求められている。事務局は、市民社会組織の間で RFMO における透明性の欠如に関する広範な批判が一般的に行われている一方で、これらは CCSBT を直接的に標的としたものではなく、また本委員会では行われていない慣行を批判するものであることが多いことを確認した。例えば CCSBT は全ての補助機関の会合にオブザーバーが関与することを許容しているが、これは他の RFMO では必ずしも当てはまらない。また、会合による決定は、会合の終了から数日以内に公開されることが通常となっている。

It appears that what criticisms were received as part of the Performance Review process were primarily related to the use of Heads of Delegation meetings where observers are excluded. In its review, the Secretariat has found that the use of Heads of Delegations is largely constrained to those instances where allocation negotiations are involved or discussions relating directly to personnel appointments. The Secretariat argues that maintaining confidentiality around sensitive topics such as allocation is essential to reaching consensus and/or allowing candid conversations between Members. The Secretariat further suggest that this item is largely addressed through the actions undertaken under **PR2021-56**, which aim to minimise the use of Heads of Delegation meetings.

パフォーマンス・レビューのプロセスの中で CCSBT が受けた批判は、一義的にはオブザーバーが排除される代表団長会議の利用に関するものであったようである。事務局がレビューしたところでは、代表団長会議の利用は国別配分量の交渉が関係する場合、又は人事の任命に直接関係する議論が行われる場合にほぼ限定されていることを確認した。事務局としては、コンセンサスに到達するため及び／又はメンバーによる率直な議論を可能とするためには、特に国別配分量のような機微なトピックに関する機密を保持することが必要不可欠と考える。また事務局は、この行動項目は、代表団長会議の利用を最小化することとした **PR2021-56** に基づく行動項目を通じて概ね対処済であるものと考えている。

Review of Strategic Plan

戦略計画のレビュー

The current Strategic Plan covers the period from 2023 to 2028 and consideration should now be given to its next iteration. The past practice at CCSBT has been to undertake an independent Performance Review to support the development of the Strategic Plan. Should Members wish to retain this approach then preparations for this process will need to begin in 2026 with the development of revised Terms of Reference. Once Terms of Reference for the next review have been adopted, the Secretariat will be able to develop a workplan and budget for the work required. An indicative timeline for the next review is provided below:

現行の戦略計画は 2023 年から 2028 年までの期間を対象としており、次期計画の策定に向けた検討を開始する必要がある。CCSBT におけるこれまでの慣行では、戦略計画の策定を支援するために独立パフォーマンス・レビューを実施してきた。メンバーが同様のアプローチを継続することを希望する場合には、改訂付託事項の策定と合わせて、2026 年から準備作業を開始する必要がある。次回のパフォーマンス・レビューの付託事項が採択されれば、事務局は必要な作業に係る作業計画及び予算

案を作成することが可能となる。次回のパフォーマンス・レビューにかかる暫定的なスケジュールは以下のとおりである。

Next Steps

次のステップ

In 2024, the EC considered relevant items of the Strategic Plan following the agreed template and adopted its “Report from the Extended Commission on Progress Against Strategic Plan” as Attachment 12 of the report of EC 31.

2024年において、ECは合意されたテンプレートを用いて戦略計画の関連行動項目について検討し、EC 31 報告書別紙 12 として「戦略計画に対する進捗状況に関する拡大委員会からの報告」を採択した。

For the EC’s discussion to update this progress report, the Secretariat has provided some initial views on updates against items assigned to the EC as tracked changes (see

Attachment B). Members are asked to update the assessment of progress against those activities assigned to the EC, by updating the previously agreed reporting template in Attachment B.

ESC supports the vision as described here. ESC has contributed to SBT stock rebuilding and management advice based on scientific evidence. The ESC considers that the SBT tuna stock is being rebuilt towards a biomass level that will support the MSY. The most recent stock assessment indicates that the stock is rebuilding at approximately 5% per year and is currently estimated to be at 23% of TRO₀. The ESC notes that demonstrating progress towards stock rebuilding has and will continue to rely on the substantial investment in innovative science including in genetic studies that has allowed a robust estimate of population size to support decision making on TACs, monitoring stock recovery and demonstrating progress towards the rebuilding targets. The current MP is based on sound science and processes which are unique in their approach to tuna fisheries management relative to approaches in other related RFMOs. The ESC provides advice on TACs based on a fully tested management procedure (MP). The ESC also applies an annual metarule framework to the MP that includes an annual review of indicators and a process to assess whether or not exceptional circumstances have occurred. The ESC notes advice from the ERSWG to the EC on ecologically related species, including seabirds. While not the responsibility of ESC, marine pollution and human safety is an important issue.
Operation/Administration of the Commission and Secretariat It was agreed the Commission should operate effectively and efficiently, to responsibly manage fishing for SBT.	ESC supports the strategic goals on the operation/administration of the Commission and Secretariat, and considers that opportunities for harmonising with other RFMOs should continue to be pursued, including for developing electronic monitoring (EM) standards. The ESC has regularly reviewed and updated the Scientific Research Plan as well as the associated schedule and budget implications.

This includes strategies for effective and efficient operation of Commission, its subsidiary bodies and Secretariat, including harmonisation with other RFMOs.	The Commission and Secretariat should be aware of any implications that arise from the BBNJ agreement.	
Participation and implementation by Members, including Compliance Members are actively participating in management of SBT through the Commission and implementing its decisions. This includes strategies concerning MCS, sanctions and assistance to developing countries.	The ESC also considers there has been progress with participation in ESC meetings and will continue to work toward the goal of maximising participation by all Members. Management of SBT The Commission agrees the SBT tuna stock is to be managed at a biomass level that supports the maximum sustainable yield, and the risks related to fishing for SBT and impacts from fishing for SBT on ecologically related species are mitigated. • This includes strategies concerning stock rebuilding, allocation and ecologically related species. • This also includes consideration and review of all other risks including, but not limited to, marine pollution and human safety.	<i>Strategies concerning stock rebuilding</i> The EC has adopted and implemented measures to rebuild the SBT stock based on the scientific advice/recommendation from ESC, EC supports continuation of the scientific studies and research which would enable the ESC to come up with a robust estimate of population size and more precise stock assessment and risks on future assessments. The implementation of the commission decisions are evaluated in the compliance meeting. <i>Strategies concerning ecologically related species</i> The level of interaction between seabirds and SBT fisheries remains a significant concern for the EC. CCSBT Members have been advised by the ERSWG to consider taking further actions that would ensure robust seabird mitigation measures and effective monitoring of implementation of the mitigation measures, whilst minimising impacts on SBT surface longline fisheries effort but to date no actions have been taken by the EC regarding that advice. <u>The ERS Tech 2025 Progress has been made towards</u> completing a Spatially Explicit Fisheries Risk Assessment (SEFRA) for seabirds. Further refinement of this assessment together with actioning the Commission's Multi-year Seabird Strategy is expected to guide much needed action to ensure robust seabird mitigation measures and effective monitoring, whilst minimising impacts on SBT surface longline fisheries effort.

	<i>Consideration and review of other risks (pollution and human safety)</i> Although there have not been discussions in the Extended Commission recently on the issues such as marine pollution, and human safety, the EC may wish to consider adopting the rules of other relevant RFMOs on these issues.
